




Rates

Contracted rates are quoted in Qatari Riyals (QAR) per room per night, and are valid until December 31st 2024

Room rates are inclusive of buffet breakfast, served in the All Day Dining Restaurant, and are subject to hotel availability at the time of booking. The rates above are for individual bookings only, and are not applicable for groups, conferences, meetings, and city wide events. Any bookings for 10 rooms and above will be quoted separately.

As recognition of the agreed negotiated corporate rates, UNIVERSITY OF DOHA FOR SCIENCE AND TECHNOLOGY is expected (without obligation) to produce approximately a combined yearly production of 200 room nights at the Wyndham Doha West Bay. The hotel reserves the right to re-evaluate this agreement after reviewing the number of

Reservations

All reservations must be guaranteed with one-night room charge either by cash deposit or credit card. The Hotel will accept voucher payment if credit facilities with the Hotel have been set up. Credit will only be granted if a credit application has been filled out and approved by the Hotel's credit department. If credit facilities are declined, all reservations have to be prepaid in full (room and meals – as per meal plan) for the entire stay of the guest (s). Full prepayment will be based on the services requested in writing by the Business Partner.

Cancellation & No-Show Policy

Any guaranteed reservations that do not materialized, will be classed as a No–Show and charged one (1) night including applicable taxes. To avoid cancellation charges, any cancellation must be sent in writing by your company to reservations 24 hours prior to the date of arrival. Any cancellations received after and within 24 hours prior to arrival will be subject to one (1) night charge including applicable taxes.

Check -in / Check-out

Check-in time: 15:00hrs.

Early check ins between 08:00hrs. to 15:00hrs. are subject to early check-in charges of 50% of room rate.

For early check ins between before 08:00hrs. full day room charge applies. Early check-in/s are subject to availability.

Check-out time: 12:00hrs.

Check Outs after 12:00hrs. and before 18:00hrs. will be charged at 50% of the confirmed room rate. Check-Out after 18:00hrs. will be charged as one full night of the confirmed room rate. Late check-outs are subject to availability.

Children Policy

Up to 2 Children below the age of 6 stay for free in the parents' room on existing bedding. Extra beds are charged at QAR 150 per night, and are subject to availability. Baby cots are free of charge.


Up to 2 children below the age of 6 eat for free in the all-day dining restaurant only. This is not applicable for à la carte orders, and parent's room must be booked on Bed & Breakfast basis.

Children between the ages of 6 and 12 get 50% discount on the buffet breakfast.

Payments and Credit Facility

Unless credit has been established with the hotel, all room charges are to be settled directly by guest credit card or through cash settlement from the company prior to guest departure. In the event of credit being established and approved, full payment should be made within 30 days of receipt of hotel's invoice. The Hotel will extend credit to the Client subject to a final approval by the hotel management. Credit Facility application forms can be obtained from the Sales & Marketing Office.





For accounts with approved credit extension, a letter of undertaking on company letterhead Letter of Purchase Order (LPO) together with the authorized signatory is to be received 3 days prior to arrival date.

Unless the hotel has confirmed credit facilities all reservations have to be pre-paid in full (room & meals – as per meal plan) for the guest's entire stay.

For accounts on pre-payment basis, the estimated amount of the total room nights of total rooms reserved is to be received 3 days prior to arrival date. Balance of room nights due is to be settled by cash or credit card prior to the departure of the guest(s). Advance pre-payment, where requested, must be received by the dates indicated, or reservations made become invalid and rooms will be released for re-sale.

Value Added Tax

It is understood and agreed between the Parties that any and all sums payable pursuant to this agreement, including but not limited to, rooms rate, rental fees, food and beverages charges and third-party fees, shall be deemed to be exclusive of Value Added Tax (VAT) and any other government imposed taxation unless otherwise stipulated. Any ValueAdded Tax chargeable in respect of the services provided by the Hotel shall by paid by the Customer/ Client in addition to the sum agreed to be paid hereunder. Value Added Tax will be charges as per the legal rate at the time of the payment

Force Majeure

All rooms that may be reserved are subject to the inability of the Hotel to provide such accommodation as a result of acts of God, acts of government or other authorities, wars, hostilities, civil disturbances, strikes, riots, epidemics and quarantines or as a result of any cause beyond the control of the Hotel.

The Hotel shall incur no liability to provide any accommodation reserved thereby, if such inability is due to any of the causes listed above.

On the other hand, the Hotel shall not make the Client liable or reimburse any amount in case of any cancellations pertaining to the room reservation booked prior to the event as mentioned above.

Confidentiality

Rates agreed in this contract are confidential between the Hotel and the Client and must not be disclosed under any circumstances. The offered rates cannot be advertised or placed online to the public without prior written approval from hotel.

Miscellaneous


